### Dentist Job Search and Dentist Employee – TERMS OF SERVICE

Jointly you (the Employee) and Dentist Job Search (DJS) agree to the following:

- DJS agrees to supply details of any vacancies that are in the Employee's nominated areas and suit his / her specific requirements.
- DJS agrees to produce an introductory resume on behalf of the Employee using information provided by the Employee in the questionnaire.
- DJS will promote the Employee's initial interest and availability in the preferred employment options by forwarding the introductory resume to prospective employers.
- DJS will endeavour to provide the Employee with the maximum number of employment options in the selected localities.
- DJS agrees to continually promote the Employee to positions in the selected localities until a position is located which is acceptable to the Employee.
- Upon receipt of an expression of interest by the employer in the Employee, DJS will immediately arrange contact between the two parties.
- DJS agrees to hold in confidence any information which is requested by the Employee to be so retained in confidence.
- DJS agrees to adhere to Australian Equal Opportunity Legislation.
- DJS maintains an employment file for each Employee providing a chronological record of all positions discussed and all promotions to prospective employers.
- DJS will be responsible for arranging all employment placements for the duration of the Employee's Visa. Placements will be arranged in consultation with the Employee.
- DJS will negotiate the best possible remuneration package on the Employee's behalf.
- Although DJS endeavours to match employees to employers as well as possible, the decision to accept work rests solely with the employee. DJS will not be responsible for the Employer's competence or character or the employee's suitability to the job.
- DJS accepts no responsibility for any cost, damage or loss to the employee arising from any behaviour, action or failure by the employer.
- DJS will supply employment options for the Employee. Whilst every effort will be made to secure employment for the Employee, DJS can in no way be held responsible in the event that suitable employment options are unavailable for any period or periods of time during the Employee's stay in Australia.
- Nothing contained in these terms shall create the relationship of employer and employee between DJS and the Employee.
- The Employee agrees to hold in the strictest of confidence all information gained during the employment process. Information pertaining to location of positions or identities of prospective employers is not to be shared with colleagues.
- The Employee agrees to advise DJS immediately if there is a change to their telephone or postal contacts.
- The Employee agrees to advise DJS immediately if there are any changes to their employment requirements.
- The Employee agrees to advise DJS immediately they accept an offer of employment.
- The Employee takes full and sole responsibility to secure registration with the appropriate state dental board in which the employment is located. DJS will provide details of registration board contact details and requirements.
- The Employee agrees to report to DJS immediately of any variation to their employment.
- The Employee agrees to diligently carry out their clinical duties as required and shall act within the dentist's Professional Code of Ethics at all times.
- The Employee agrees to abide by Australian Law and will depart Australia by the Visa's expiry date.
- The Employee will give DJS two weeks notice of any intent to leave/ discontinue sponsorship with DJS
- DJS makes no guarantees that DIMIA will accept your application and cannot reimburse any costs incurred should DIMIA reject your application.
